PROFILE OF SKILLS AND COMPETENCES

The holder has acquired general skills relating to:

Producing tapestries and carpets using the different techniques, processes and materials used in traditional trades and also more current approaches, developing both with sensitivity and artistic ability.

The LOGSE (the General Organisation of the Educational System Law) endowed these techniques, processes and artistic activities with an academic framework and thereby instrumentalised the training, professional and occupational operativity of certain deeply rooted traditional artistic modalities. The purpose of this training cycle is to attain in-depth knowledge of the production of tapestries and carpets and the technique that should be used in each case, together with how to handle the different materials, and knowledge of and practice in the necessary tooling, not to mention a strong artistic preparation, necessary to achieve the quality that this type of work demands.

Within this framework, each PROFESSIONAL MODULE includes objectives leading to the following LEARNING RESULTS that the holder acquires.

“Dibujo” (drawing)

The title holder:

- Develops his or her creativity, aesthetic sensitivity and their expressive and communicative capacity.
- Captures an image of his or her surrounding objects and is able to represent and reproduce that image graphically using different plastic and technical methods.
- Creates and interprets sketches, drawings and blueprints and knows and interprets the rules and other graphic information related to the artistic-artisanal and ornamental creation appropriate to this speciality, in a two-dimensional representation thereof.

“Color” (colour)

The title holder:

- Possesses general knowledge of colour and chromatic composition.

- Knows the basic factors and relationships that intervene in chromatic behaviour and in the perception of colour.
- Uses the various techniques and procedures correctly.
- Develops his or her creative ability and artistic sensitivity through specific work.

“Historia de la Cultura y del Arte: textiles artísticos” (history of culture and art: artistic textiles)

The title holder:

- Attains the necessary knowledge of major past and present cultural and artistic cycles.
- Develops his or her intellectual personality and completes their artistic and technical training.
- Knows the essential aspects of the ideological, political, economic, social and aesthetic context in which the textile arts have been generated throughout History with special reference to tapestries and carpets.

“Taller de tapices y alfombras” (tapestries and carpets workshop)

The title holder:

- Possesses the knowledge, skills and attributes that allow him or her to correctly execute techniques specific to the speciality.
- Uses the workshop materials and equipment properly.
- Knows and knows how to use the different textile techniques and materials, assessing their expressive possibilities.
- Develops his or her creativity and artistic sensitivity.
- Fosters the research into and the analysis, classification and learning of the textile techniques that traditionally are deeply rooted in the geographical environment of educational centres.

“Formación y Orientación Laboral” (training and career guidance)

The title holder:

- Knows the legal working framework and the rights and obligations that derive from labour relations.
- Possesses the economic, commercial and social knowledge that makes it possible to administer and run a small and medium-sized company, or to work as a self-employed professional.
- Possesses specific knowledge as to the labour market access mechanisms and selection systems, and the skills that make it easier to find work.
- Knows the institutional bodies, both national and community, that help labour insertion and the services that provide economic aid and subsidies for entrepreneurial initiatives and self-employment.
- Knows the legal, corporate and professional instruments specific to the speciality.

RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Holder of a Diploma of Education in Plastic Arts and Design in Tapestries and Carpets carries out his or her professional activity in companies in the textile sector, and in others within other industrial production sectors that require the services of such professionals given that they use among their components textile elements specific to or related to the production of tapestries and carpets; in companies and workshops of an artisanal or artistic nature, whether public or private, small, medium-sized or large, related to the professional field of tapestries and carpets; as a freelance professional or an associate in a cooperative; under the direction of more senior technicians or others from other academic fields, carrying out projects that use components from the professional field relating to tapestries and carpets; in providing consultation services on tapestries and carpets to independent professionals or artists; or in carrying out projects of an artistic nature that they themselves, other graduates or artists have created.

OFFICIAL BASIS OF THE CERTIFICATE

Name and status of the body awarding the certificate: The Ministerio de Educación, Cultura y Deporte (the Ministry of Education, Culture and Sport) or the Autonomous Communities in the area of their own administrative responsibility. The degree has academic and professional effects that are valid throughout the entire State.

Official duration of the Diploma: 1,600 hours.

Name and status of the body awarding the certificate.

- NATIONAL: Post-compulsory secondary education.
- INTERNATIONAL:
 - Level 3 of the International Standard Classification of Education (ISCED3).
 - Level ----- of the European Qualifications Framework (EQF-----).

Entry requirements: A Graduate Degree in Secondary Education, or a Certificate of having passed the corresponding entrance test.

Access to the next level of education or training: Will be able to access Higher Level Training Cycles, subject to passing an entrance test.

Legal basis. Rules and regulations on which the Diploma is based:

- Minimum teaching requirements established by the State: Royal Decree 1623/1997, of 24 October, which establishes the Diploma of Education in Plastic Arts and Design in

Tapestries and Carpets, which belongs to the professional family of Artistic Textiles, and approves the corresponding minimum education requirements.

Explanatory note: This document is intended as supplementary information to the Diploma in question, but on its own it does not have any legal validity. It may be accompanied by an Annex I which the corresponding Autonomous Community shall fill in.
